# The Board Certification Process Will Change as of October 14, 2006

Candidates with five years of documented clinical or research experience in the field of wound care are eligible to sit for the exam. As of January 1, 2007, a Bachelors Degree or higher will be necessary in order to qualify to sit for the National Board Certification Examination for all Wound Management Professionals.

The AAWM National Examination for Board Certification in Wound Management from the American Academy of Wound Management is held every April and October at selected testing centers nationwide. The next upcoming CWS exam will be administered on October 14, 2006. Materials Deadline: September 1, 2006.

# Change in Candidate Admission for CWS Exam



Joseph M. McCulloch, PhD, PT, CWS, FAPTA, FCCWS Candidates with five years of documented clinical or research experience in the field of wound care are eligible to sit for the exam. As of January 1, 2007, a Bachelors Degree or higher will be necessary to qualify to sit for the National Board Certification Examination for all Wound Management Professionals.

Candidates wishing to sit for the exam under the current admission criteria must submit their exam materials by September 1, 2006 for the October 14, 2006 exam date. The AAWM shall grant Diplomate status to those individuals who successfully pass the National Board Certification Examination for Wound Management Professionals. Such Diplomates shall be referred to as "Certified Wound Specialists® of the AAWM" and shall be entitled to use the title of Certified Wound Specialist and the designation CWS® after their name. There are currently 2,380 "Certified Wound Specialists® of the AAWM".

# Members' Reports Secretary/Treasurer

t is with pleasure and honor that I carry out my second term as the Secretary/Treasurer of the American Academy of Wound Management (AAWM). During my tenure, we have seen some exciting changes and growth. I'm proud to report that the AAWM has implemented a new investment strategy to increase our rate of return on our assets. This was initiated in the first quarter of 2006 and done through the help of an outside consultant, a Certified Financial Planner with expertise in this arena. It is a huge departure from the past when our assets were not returning as much income as they could. An Investment Policy Statement was developed and is available for your review.

The reason for these changes concerns some of the following areas as they relate to our economy: the Federal Reserve raised short-term rates twice this year and the Federal Open Market Committee (FOMC) increased the rate to 4.5% in January and again in March to 4.75% since the new Fed Chairman started. This marks 15 consecutive increases since June 2004 and raises the rate to its highest level in five years. The Fed has indicated that it may take further hikes in 2006 to sustain economic growth while controlling inflation. The following are ancillary reasons as to why we made changes: to reduce inflation risk to due rising gasoline prices (up 30 cents in March 2006 alone); softening housing market; higher commodity prices; a falling dollar; and the aftermath of Hurricane Katrina. All these events affect interest rates in one form or another.

As a Board we have taken measures to immunize the AAWM's portfolio against these risks mentioned above, to ensure a good return, and above all, safety of principal. These factors are always uncertain as to their timing and extent as we do not make any promises of future performance. In addition, we are preparing to undergo an audit this spring and will enlist the consultation of an outside Certified Public Accounting firm to engage in this activity.

My duties as the Secretary/Treasurer are additionally to carry out the Academy's bylaws in a prudent and ethical manor, keeping meeting minutes and generally performing as the custodian of the corporate records. ### Examination Committee

The American Academy of Wound Management takes great pride in the multidisciplinary credentialing process it has established. Since the organization's inception, the process has grown from one of certification by portfolio, through the development of a challenging and valid examination, and finally to a rigorous recertification self assessment tool. All of these efforts have been carried out under the supervision and direction of an Examination Committee consisting of members from a variety of professional backgrounds.

The Examination Committee has been chaired, for the past several years, by Joseph McCulloch, PhD, PT, CWS, FCCWS, FAPTA. Also serving on the committee are members of the Board of Directors and other Certified Wound Specialists® which include: Mona Baharestani, PhD, ANP, CWOCN, CWS, FCCWS; Kimberly Barcia, RN, BS, CWS; Charles Gokoo, MD, CWS, FCCWS; Todd Goodman, DPM, CWS; Heather Hettrick, PhD, PT, CWS, MLT, FCCWS; Donald Mrdjenovich, DPM, CWS, FCCWS and Wayne Stuart, MD, CWS, FCCWS. This core committee is supplemented by Certified Wound Specialists® from around the country that are called upon to assist with test item reviews. Such reviews take place twice a year.

This past year marked the 10th Anniversary of the American Academy of Wound Management, and with this milestone came the deadline for recertification of the first cohort of specialists certified in 1995. Recertification involves the completion of a case based home study self assessment with a mandatory passing score. Specialists are encouraged to use all resources available to them to complete the assessment which is designed to serve as a learning tool. The first two versions of the recertification exam were developed under the direction of the Recertification Subcommittee consisting of: Joseph McCulloch, PhD, PT, CWS, FCCWS, FAPTA; Mona Baharestani, PhD, ANP, CWOCN, CWS, FCCWS; Kimbery Barcia, RN, CWS; Tyrone Davis, DPM, CWS; Stan McCallon, MPT, CWS, FCCWS; Donald Mrdjenovich, DPM, CWS, FCCWS; Greg Robicheaux, MD, CWS, FCCWS and Richard Simman, MD, CWS, FCCWS.

Most recently, the AAWM approved a policy standardizing the requirements for credentialing as a Certified Wound Specialist<sup>®</sup>. Starting in 2007, individuals wishing to sit for the CWS® examination must possess the minimum of a bachelor's degree and the requisite clinical experience. In order to address the needs of those individuals involved in wound care who do not hold a Bachelor's degree, the AAWM has authorized the establishment of a new category termed Certified Wound Associate (WA-C)®. In order to qualify for credentialing in this category, individuals must have at least five years of documented experience in wound care and pass a certification examination. The WA-C<sup>®</sup> examination is currently under development. A subcommittee, chaired by Stan McCallon, MPT, CWS, FCCWS, has worked to develop a Task Analysis Survey that is currently being sent to all CWS's®. The results of this analysis will be used to develop the blueprint for the new examination. It is anticipated that the first examination will occur in the spring of 2007. Individuals with less than a Bachelor's degree, who currently hold the CWS® designation, will retain their certification as long as they meet recertification requirements. More information on this new credential will be forthcoming.

### Exam Questions: Always Needed!

The American Academy of Wound Management is challenging all CWSs to write at least one question for the Exam Committee for potential submission to the Board Certification Examination for Wound Management Professionals.

Some guidelines for writing questions:

- 1. They must be multiple-choice format
- 2. They must have four possible answers (with the correct answer identified)
- 3. They must have a referenced source with each question
- 4. They should be designed for participants to recall, understand, apply or evaluate

AAWM is also looking to include case studies with photographs for future examinations. When submitting a photograph/digital image, the same question guidelines apply, as well as the following for photographs:

- Photographs/digital images may be in either color or black/white (no Polaroids)
- 2. If using a digital camera, a high-resolution setting produces quality images
- 3. The area of interest should be clear and easily identifiable
- 4. Patient privacy must be respected; no names or identifying information may be visible

5. If possible, a ruler (in cm or mm for scale purposes) should be visible in the photograph

Please remember that all case studies and photographs/digital images become the property of the AAWM for use as determined by the AAWM.



# Differences Between AAWM & CCWS™

ike many certifying boards, an entity such as a college is developed to complement and carry out tasks that a credentialing body in itself is not capable of doing. One cannot become a Fellow of The College, FCCWS, without possessing a CWS<sup>®</sup>. It should be stated that these are two separate and distinct organizations, however, these two organizations coexist to complement each other. As an advocacy arm of the AAWM, The College will provide educational endorsements of exam prepatory courses, research grants, and provider and public relations, as well as political activism to promote the CWS<sup>®</sup> credential. The main differences follow:

EXAM PREPARATION	The CWS® examination is a self-preparation exam. We offer an outline of the exam in our Candidate Handbook as well. As a certifying organization, The Academy cannot endorse wound care courses or textbooks related to the CWS exam.	Beginning in year 2006, the Education Committee of The College will develop and provide continuing education short seminar/workshop type courses that address a variety of topics related to wound healing. The courses will be designed for CCWS <sup>™</sup> members who wish to take refresher courses and for non-member health care practitioners who wish to prepare for taking the American Academy of Wound Management CWS <sup>®</sup> examination, and courses for those members who wish to advance their understanding of current wound management topics.

#### ACTIVE COMMITTEES

#### American Academy of Wound Management (AAWM)

**Exam Committee** Responsible for oversight of the examination process. Meets at least annually to approve examinations for the calendar year. Subgroups of this committee are also responsible for serving on Item Review sessions and with the Recertification Committee. However, no more than 50% of the members of the Exam Committee can serve on the Recertification Subcommittee.

**Exhibit Committee** Mission: to support, promote, and expand the recognition, membership, and validity of the AAWM and the CCWS<sup>™</sup> via exhibition at professional conferences and symposia across the country.

AAWM exhibits at the following conferences: Symposium for Advanced Wound Care; Clinical Symposium on Advances in Skin & Wound Care; Wound Care Congress; American Burn Association; Wound Ostomy Continence Nurses; American Burn Association; New Cardiovascular Horizons

Item Review Committee Ad hoc committee, formulated each year to assist with reviewing of new test items being added to our test item bank. Is representative of the major disciplines certified by the Academy and has limited participation from members of the Exam Committee. Membership on this committee is determined annually by the Exam Committee Chair.

**Marketing Committee** Mission: to attract new members to be board CWS<sup>®</sup> and to develop name recognition for the AAWM and the CWS<sup>®</sup> designation.

The Marketing Committee promotes their goals by:

• Advertising in industry publications (i.e. magazines, newsletters, journals, etc.) with informative articles, advertisements and editorials.

• Mail and e-mail press releases to healthcare industry publications.

 Position AAWM members to speak on wound management ment and the CWS<sup>®</sup> designation at the educational meetings of related organizations.

• Distribute National Registry of Board Certified Wound Specialists guide as part of a press kit to medical societies on the state and national level.

• Promote the importance of the CWS® designation to patients through literature.

**Recertification Committee** Responsible for oversight of the recertification process. Meets as necessary to approve new versions of the recertification examination. Membership on this committee is determined by the Exam Committee Chair and represents the major disciplines certified by the Academy. Anyone within two years of their recertification date is prohibited from serving on the committee. No more than 50% of the members of the Exam Committee can serve on the Recertification Committee.

#### The College of Certified Wound Specialists™ (CCWS™)

Education Committee Mission: to provide continuing education wound seminar/workshop courses in preparation for the AAWM CWS® examination, and courses for those members who wish to advance their understanding of current wound management topics. Will be made up of individuals from several health care disciplines including but not limited to: nursing, medicine, physical therapy and podiatry.

Industry Committee At the present time The College is presenting opportunities for Industry Sponsors. These areas will comprise funding and unrestricted grants for: Receptions and Exhibits at National Conferences and Work Shop Sponsorships and Journal Sponsorship.

**Research Committee** To assist in evidence-based projects by providing funding for credible wound management projects. The Research committee is developing other areas of research at this time.

Political Action Committee Building on the first three objectives, The College intends to add substantial credibility to the CWS® by elevating the standards of wound management. One method to achieve this is to encourage all health professionals involved with wound management to become certified by an accredited organization (e.g. AAWM or WOCN). In addition, establishing alliances with other national and international wound organizations will help to foster ideas and goals to strengthen wound management worldwide.

**Provider Relations Committee** Mission: Raising the "awareness" of the presence of an advanced level of wound care practice with the opportunity to provide "Best Practice Care." The committee imparts information to focal awareness groups that the most excellent outcomes are provided by those most educated, trained and certified as Advanced Wound Care practitioners.

The Provider Relation's Committee will work to heighten awareness groups that include:

- Consumers and community
- Providers (hospitals, wound care clinics, etc.
- Payers (CMS policy makers-reimbursement)

• The wound care product industry governmental and private payers (Medicare/Medicaid, insurance companies—i.e. HMOs/PPOs, etc.)
